### Notification of the voting rights total amount

**Genoa, 5 March 2026** – ERG S.p.A. hereby announces that on 19 February 2026 there was a change in the Company's voting rights as a result of the request for cancellation from the list of increased voting rights relating to 91,000 ERG ordinary shares with increased voting rights, pursuant to art. 127-*quinquies* of Legislative Decree 58 of 24 February 1998 and in accordance to the Articles of Association.
